ADDITIONAL PROVISIONS

- Working day is every day from Monday to Saturday, except holidays, in which the Bank receives payment orders for execution in line with the working hours of its branches, i.e. the time when the receipt of electronic transfer orders is enabled. For internal orders, Saturday is also considered as a working day.
- > Working day for Instant payment orders is every calendar day with no exception.
- Instant order is:

<u>Transfer order</u> up to amount of RSD 300.000 (including this amount):

- o submitted at the Bank's branch
- entered by electronic or mobile banking

Payment order for crediting up to amount of RSD 300.000 (including this amount).

DEVIATIONS FROM AND CHANGES OF THE TERM PLAN
